- PERMITS TO BE COMPLETED AND SUBMITTED NO LATER THAN 3:30 P.M.  
REGULAR BUISNESS DAYS  
PERMITS RECEIVED AFTER THAT TIME WILL BE RESPONDED TO ON THE  
NEXT OF REGULAR BUSINESS DAY
- AWAIT PERMIT APPROVAL OR DENIAL STATUS PRIOR TO ANY BURNING
  - ONCE PERMIT IS SUBMITTED TO THE MUNICIPAL OFFICE,  
CONFIRMATION OF DECISION WILL BE PROVIDED TO THE APPLICANT  
ON FIRST COME, FIRST SERVE BASIS BY A MUNICIPAL STAFF MEMBER
  - **PLEASE NOTE THAT MUNICIPALITY OF SOURIS-GLENWOOD FIRE  
CHIEFS ARE VOLUNTEERS SO PLEASE ALLOW TIME FOR THE PERMIT  
DECISION TO BE DETERMINED**
- BURNING IS ONLY ALLOWED ON THE DATES LISTED ON THE PERMIT IF  
BURNING WAS UNABLE TO OCCUR, A NEW PERMIT MUST BE SUBMITTED
