The Municipality and Owner agree as follows:

1. Prior to requesting snow removal, the Owner must have a completed signed Snow Removal Consent Form and waiver. The Owner agrees to complete this form on an annual basis or in each year prior to snow removal being undertaken. For simplicity all agreements will run from October 1st to April 30th.
2. The Owner agrees to pay a Minimum of \$50 +gst for up to 15 minutes of work, and anything more than 1 hour will be charged at \$215/hr +gst. In the event work charges are not paid within 30 days of billing, the Owner agrees that interest will be added at a rate of 2% per month and any unpaid bills will be added to and form a part of the owner's property taxes at year end. The Municipality may refuse services for delinquent accounts. Prices are subject to change.
3. In the event the Owner is not the occupant/requestor, payment must be made prior to the work being undertaken.
4. The Municipality shall have the right to refuse to undertake snow removal on any private driveway that in the opinion of the Municipality and its operators will be hazardous or difficult to undertake, too narrow or overgrown trees etc. Objects that are concealed because of snow coverage must be marked with stakes or otherwise.
5. The Owner hereby covenants and agrees that he/she will at all times indemnify and save harmless the Municipality, its servants, agents and employees from and against all loss, damage or injury however caused to the Owners property and the Municipality's equipment.
